A motion was made by Comm. Perdun to accept the recommendation of the Planning & Zoning Board to approve the petition of Jodell Langdon to rezone the property at 401 E. For now, the hours would be Thursday, Friday, and Saturday 11:00 a.m. to 4:00 p.m. With a liquor license to sell wine or beer she may be open in the evening from 3:30 pm to 7:30 p.m. She had talked to all the neighbors and they expressed no concerns. 401 E FAIRGROUNDS REZONED R-2 TO B-3

A motion was made by Comm. Perdun, seconded by Comm. Stork, to approve the Supplemental No. 1 Preliminary Engineering Services Agreement for Project IL Hwy 109 @ W. County Rd. Curt Westrich, Heneghan & Associates, had explained to the Council that this agreement not only designates that Motor Fuel Tax Funds, allotted to the City, by the State of Illinois, under the supervision of the IDOT may be used for the engineering services as outlined in the agreement, but also describes the preliminary/ construction engineering services as noted in Attachment "A". He also explained the necessary revised scope of work which includes a shared-use 10' sidewalk which includes a bike path with the required additional curb & guttering, and storm sewer adding about \$450,000 to the project. On the design side it will now have to have 15 parcels of land that need to be acquired instead of the original 4 parcels, additional work at the intersection, additional traffic studies, and surveys. Comm. Perdun said that the original IDOT grant was \$440,000 plus a grant for \$110,000 then IDOT will do the construction engineering for \$150,000, which is \$750,000 besides our share of the project. How can we be sure that the State's offer will be good for 4 years? Curt said that the City needs to write a special letter asking for their guarantee that the funds will be available at the end of this project. We are looking at a bid letting of January of 2017, with construction done in the summer of 2017 and the payment to be due and payable in the Fall of 2017 or 6 to 8 months after the completion of the construction. Comm. Stork asked if we could lose the state money due to the State's budget impasse? Westrich felt that if the State saw some progress they would keep the money available for us. Roll call vote showed all ayes, no nays, motion carried.

A motion was made by Comm. Goetten, seconded by Comm. Pohlman, to accept the 5 year agreement with Central States Fireworks in the amount of \$10,000 per year. With this agreement, Central States agrees to an additional 10% product increase added to each year's display and an understanding of misfired units to be added to the following year's display with a 50% addition. Roll call vote showed all ayes, no nays, motion carried.

COUNCIL APPROVES FIREWORKS AGREEMENT

Director Angela Sullivan announced that the annual garage sale would be this Saturday at the Complex. Thirty tables had been reserved so far and admission would be \$1. Under Public Comments, Mike Bridgewater asked if anyone from the City had a conversation with American Water or the Railroad recently. Mayor Russel said that he had not, but he knew that American Water had wanted to talk to our employees with the permission of the union. Jeff Risley, Bartlett & West, had met with the Railroad. Attorney Strang announced that a special meeting would be held on Thursday, 3/3/16, to discuss applying for Transportation Investment Generating Economic Recovery (TIGER) Grants and Nationally Significant Freight and Highway Projects (Fastlane) Grants under the Fixing America's Surface Transportation (FAST) Act. The City has to apply for the grants, but we don't have to be the entity to own the property. Mayor Russell added that this opportunity is a result of a call made by Congressman Davis and the availability of these grants which have some quickly approaching deadlines.
